

Terms & Conditions

This Agreement sets forth the terms and conditions under which Allied Telesis may offer a promotion on the AT-SBx908 8 slot advanced Layer 3+ modular switch, in its sole discretion, its eligible Reseller Partners, as defined and set forth below.
